INSTRUCTIONS

1. Read the conditions of issuance set forth in the NASA/MSFC PKI Subscriber Agreement at <http://nasaca.nasa.gov/docs.html> . If you accept these conditions, electronically complete MSFC Form 4378. (Note: The requester is responsible for assuring that their User ID and E-Mail Address are correct or the request will be rejected.) *
2. E-mail the completed form to your supervisor with the subject "PKI app - user name".
3. For contractors, the user's supervisor will digitally sign the request (or manually sign the hardcopy form), then forward to the appropriate NASA/MSFC COTR. Contractor management designated by the assigned NASA/MSFC COTR may apply for PKI Certificates by sending the application directly to the NASA/MSFC COTR (by either e-mail or manually). The **validity period** for a contractor application is the earliest of the contract termination date or two 2 years.
4. The NASA/MSFC supervisor or NASA/MSFC COTR will digitally sign the request. If that is not possible, then manually sign the hardcopy form.
5. The supervisor or COTR will forward the request via e-mail to PKIRA@msfc.nasa.gov. Or, if the form is hand signed, FAX the form to (256) 544-1582. Return the original hardcopy to the user (user will need it to complete step 7).
6. The RA will notify the user when the application is accepted and processed or rejected.
7. The user (in person) will verify their identity to the RA by showing their MSFC badge and any government-issued picture identification (i.e., state driver's license, etc.). The original paper form (MSFC Form 4378) with signatures, must be provided if the original was not digitally signed by the supervisor (and COTR if contractor).
8. The user (in person) will sign MSFC Form 4378-1 (NASA/MSFC PKI Subscriber Agreement) and accept the Registration Number and Authorization Code.
9. The user must activate their PKI Certificate within 14 days or the Registration Number and Authorization Code will expire and it will be necessary to reissue them.
